Section 3. Hazards Identification

Symptoms of Poisoning: Nausea, diarrheal, dripping nose and mouth, excessive salivation, stomach cramps, excessive sweating, trembling, loss of muscle coordination, muscular twitches, weakness, mental confusion, and blurred vision, breathing difficulties, rapid pulse and pin-point pupils

Section 4. First Aid Measures

Eyes: Immediately rinse eyes with a large amount of running water for 15-20 minutes. Remove contact lenses, if present, after 5 minutes, then continue rinsing eye. Hold eyelids apart to rinse the entire surface of the eyes and lids. Do not apply any medicating agents except on the advice of a physician.

Skin: Remove contaminated clothing. Wash skin immediately with plenty of soap and water, including hair and under fingernails. Do not apply any medicating agents except on the advice of a physician. Obtain medical attention if irritation persists. Decontaminate clothing prior to re-use.

Inhalation: Move victim from the contaminated area to fresh air. If the individual is not breathing, call an ambulance and begin artificial respiration.

Ingestion: If victim is fully conscious, give a large quantity of water to drink. Do not induce vomiting unless under the direction of a physician. Never give anything by mouth to an unconscious or convulsing person.

Section 5. Fire Fighting Measures

Extinguishing media: Use dry chemical, foam, or CO2 extinguishing media. Wear full protective clothing and self-contained breathing apparatus. Evacuate nonessential personnel

from the area to prevent human exposure to fire, smoke, fumes or products of combustion. Prevent use of contaminated buildings, area, and equipment until decontaminated. Water runoff can cause environmental damage. If water is used to fight fire, dike and collect runoff.

Section 6. Accidental Release Measures

Procedures for dealing with release or spill: Control the spill at its source. Contain the spill to prevent it from spreading, contaminating soil, or entering sewage and drainage systems or any body of water. Clean up spills immediately, observing precautions outlined in Section 8. Moisten the spilled material with a little water. For small spills, sweep up as much material as possible, keeping dust to a minimum and place in a marked chemical container. Wash the spill area with water containing a strong detergent (e.g. commercial products such as Tide, Joy Spic and Span), absorb with pet litter or other absorbent material, sweep up and place in a chemical container. Seal container and label appropriately for disposal. Flush the spill area with water to remove any residue. Do not allow wash water to contaminate water supplies. Heavily contaminated soil layers have to be dug out down to clean soil.

Section 7. Handling & Storage

Precautions in Handling: Keep out of reach of children. Do not eat, drink, use tobacco or apply cosmetics in areas where there is a potential for exposure to the material. Always wash thoroughly after handling. Also see section 8 below.

Storage: Store the material in a well-ventilated, secure area out of the reach of children and domestic animals. Do not store food, beverages or tobacco products in the storage area.

Section 8. Exposure Control, Personal Protection

Inhalation: Work in a well -ventilated area. A air-purifying respirator with a filter and an organic vapor cartridge may be permissible under circumstances where airborne concentrations are expected to exceed exposure limits. Protection provided by air-purifying respirators is limited. Use a pressure demand atmosphere-supplying respirator if there is any potential for uncontrolled release, exposure levels are not known, or under any other circumstances where air-purifying respirators may not provide adequate protection.

Eyes: To avoid eye contact, wear safety glasses with side shields or chemical goggles.

Skin: To avoid skin contact, wear rubber gloves, rubber boots, long-sleeved shirt, long pants and a head covering.
